MONTHLY BOARD MEETING

April 15, 2019

The Board of Education of the Hubbard-Radcliffe Community School District met Monday, April 15, 2019 in the Library at the Radcliffe School. Board members present Jacob Bolson, Leon Schwartz and Bob Westendorf presiding. Brandy Eilbeck and Keith England were absent. Others present were: Superintendent Adam Zellmer; Board Secretary Debra England and media—Corey Meints.

Bob Westendorf called the regular meeting to order at 7:07PM.

Motion by Schwartz, seconded by Bolson to approve the agenda with the addition of the Teacher Librarian Sharing Agreement with AGWSR under business item C. MC

Motion by Bolson, seconded by Schwartz to approve the minutes from the March 25, 2019 regular board meeting, April 1, 2019 special joint board meeting, April 4, 2019 special negotiation meeting and the reports on budget and warrants. MC

Mr. Mangold reported Family Movie Night was a success with a great turn-out for the event. Grades 3 -5 will begin ISASP testing on Monday, April 22nd. A Character Camp Day is being prepared for team building with the 5th graders as they prepare for Middle School. May 22 is the day planned for 5th grade students to tour the Middle School in Hubbard.

Mr. Taylor reported the Middle School is focusing on transitions for the 8th graders going to the high school and the incoming 6th grade students. On May 22 the 8th grade students will visit the high school. The 7th and 8th grade band students will be competing at Adventureland on May 4th.

Motion by Bolson, seconded by Schwartz to approve a contract for teacher Calvin Bergan for the 2019-20 School Year pending a background check and 2019-20 Teacher Leadership Team Contracts: Nicole Briggs – Instructional Coach; PLC Coach Mentors: Sarah Allison, Jessica Below, Martea Engelson, Kelly Matteson, Sarah Thompson and Dena Zoske. Motion by Bolson, seconded by Schwartz to approve employee transfers as follows: Carole Spiels to 6th Grade ELA Teacher, Sarah Thompson to Elementary Special Education Teacher and Alysha Heue to Elementary Custodian. MC
