Motion by England, seconded by Halvorsen to approve the lane change request for Nicole Nielson to move from BA12 to BA24 for the 2020-21 school year. MC

Motion by Weig, seconded by Halvorsen to approve Bo Balvanz as a volunteer Football coach. MC
