March 21, 2022

The Board of Education of the Hubbard-Radcliffe Community School District met Monday, March 21, 2022 in the Success Room at the Hubbard School. Board members present: Ashley Halvorsen, Laura Imsland, Tracey Rieks and Jacob Bolson presiding via Zoom. Bob Westendorf was absent. Others present were: Superintendent Adam Zellmer; Elementary School Principal Brian Mangold; Middle School Principal Dan Spooner; Director of Teaching, Learning & Assessment Report Sherri Walker; Board Treasurer Linda Imsland and media—Corey Meints.

Dr. Zellmer called the regular meeting to order at 7:00PM and lead the meeting due to the Zoom connection. Motion by Halvorsen, seconded by Rieks to approve the agenda. MC
